# **Statement from the Assistant Secretary of Commerce for Economic Development**

This August will mark EDA's 50<sup>th</sup> anniversary. Since its establishment under the Public Works and Economic Development Act, EDA has been supporting community strategies to help them adapt to and thrive in the ever-changing economy. During my first year as Assistant Secretary, I have had the opportunity to travel the country and see the impact of EDA's investments at the local level first-hand. I have witnessed the breadth and depth of EDA investments across the country. From Alaska to Georgia, and many places in between, I have met with community members whose economies were completely revived with help from EDA investments.

While EDA's investments are locally focused, the collective impact is felt nationally. Strengthening local and regional economies ultimately strengthens the national economy. Moreover, in our emerging role as the integrator of federal economic development efforts, EDA has led a number of multi-agency initiatives focused on growing the manufacturing sector, fostering innovation, and supporting regional resiliency. Fiscal Year 2014 was an exciting year for the Economic Development Administration in all of those areas.

In Fiscal Year 2014, EDA invested approximately \$242 million in 657 locally-driven economic development projects nationwide. These investments included approximately \$170 million in construction projects that many communities determined would enhance their local economic development efforts. Grantees expect these investments will help create or retain approximately 28,680 jobs and generate nearly \$8 billion in private investment.

In addition to the nearly \$250 million in investments across the country, EDA made significant progress on helping communities grow their economic ecosystems. FY14 was the first year EDA received funding under the America COMPETES Act as a separate and distinct program, which opened up new types of economic development projects. Our Office of Innovation and Entrepreneurship (OIE) continued to help EDA support and foster innovation across the country through the launch of its Regional Innovation Strategies Program and with the assistance of a newly appointed National Advisory Council on Innovation and Entrepreneurship (NACIE).

Early in the Fiscal year, we provided \$20.5 million in Make it in America Challenge grants. The programs are designed to encourage U.S. companies to keep, expand or re-shore their manufacturing operations—and jobs—in America, and to entice foreign companies to build facilities and make their products here. So far, these efforts are working as foreign-direct investment has been increasing and proving that America is absolutely open for business.

The Investing in Manufacturing Communities Partnership (IMCP) program is a multi-agency initiative designed to revolutionize the way federal agencies leverage economic development funds. It encourages communities to develop comprehensive economic development strategies that will strengthen their competitive edge for attracting global manufacturer and supply chain investments. In May, the first 12 communities were designated as "manufacturing communities" under IMCP. We have provided technical assistance and a federal liaison to these communities to help them enhance their manufacturing sectors.

EDA also unveiled its latest economic development tool: the Cluster Mapping website and registry, which was created by the Harvard Business School Institute for Strategy and Competitiveness. The Cluster Mapping website provides unprecedented amounts of data about clusters in a single place.

I am very proud of EDA's successes during my first year as Assistant Secretary, and I look forward to building on that success in FY15 and beyond.

#### **OVERVIEW**

#### **MISSION**

To lead the federal economic development agenda by promoting innovation and competitiveness, preparing American regions for growth and success in the worldwide economy.

The U.S. Economic Development Administration's investment policy is designed to establish a foundation for sustainable job growth and the building of durable regional economies throughout the United States. This foundation builds upon two key economic drivers - innovation and regional collaboration. Innovation is key to global competitiveness, new and better jobs, a resilient economy, and the attainment of national economic goals. Regional collaboration is essential for economic recovery because regions are the centers of competition in the new global economy and those that work together to leverage resources and use their strengths to overcome weaknesses will fare better than those that do not. EDA encourages its partners around the country to develop initiatives that advance new ideas and creative approaches to address rapidly evolving economic conditions.

#### **EDA'S ROLE**

As the only federal government agency focused exclusively on economic development, the EDA plays a critical role in fostering regional economic development efforts in communities across the nation. Through strategic investments that foster job creation and attract private investment, EDA supports development, particularly in economically distressed areas of the United States.

Guided by the basic principle that communities must be empowered to develop and implement their own economic development and revitalization strategies, EDA works directly with local economic development officials to make grant investments that are well-defined, timely, and linked to a long-term, sustainable economic development strategy.

EDA's flexible programs and structure enable nimble operations and allow for innovation and responsiveness to changing economic needs and conditions faced by its local and state government partners. Grants made under these programs are designed to leverage existing regional assets to support the implementation of economic development strategies that advance new ideas and creative approaches to advance economic prosperity in distressed communities.

EDA's economic footprint is wide and its tool box is extensive—including technical assistance, post-disaster recovery assistance, trade adjustment support, strategic planning and research and evaluation capacity, thereby allowing the agency to offer the most effective investment to help communities succeed in the global economy.

#### Alabama

In the last two years, north Alabama's economy has been devastated by the loss of several large anchor industries and the divestment of coal-fired power plants. The greatest impact has been experienced within an eight-county region that spans across the entire northern portion of the state. Plant closures and the idling of multiple power plant units have resulted in the loss of over 3,500 jobs and significant local tax revenues.

The three Economic Development Districts covering the eight-county region organized efforts led by the local communities and economic development organizations to address the long-term economic recovery of these neighboring communities. In FY 2014, EDA awarded \$300,000 collectively to fund three separate, but jointly supported, planning initiatives within the three districts. The *Shoals Area Economic Adjustment Strategy, South Bank Economic Recovery Program* and *Northeast Alabama Economic Recovery Program* are the results of the collaborative efforts of local, regional, state and federal stakeholders.

The three plans will work in conjunction to assess the long-term impacts of the job and revenue losses and recommend strategies that will focus on workforce training, asset and infrastructure development, business counseling, economic restructuring and entrepreneurial support. The investments will address the need for diversification and promote the development of "industry clusters" by looking beyond existing occupational characteristics for opportunities to support emerging, sustainable target industries. The expected economic impact will include leveraging existing regional assets to support implementation of new and creative economic development strategies identified for long-term recovery and resiliency.

As a result of the Yukon River salmon crash of the late 1990's, eight salmon processors closed their plants and left the region. In 2001, Yukon Delta Fisheries Development Association (YDFDA) set up a make-shift processing facility and began processing salmon again on the Lower Yukon. However, this plant was small and inefficient with limited processing capacity. Limited capacity meant a limited number of processing jobs to be available to the region which was facing unemployment rates exceeding 28%.

In 2012, EDA invested \$1.6 million to constructs a value-added salmon filet processing plant with blast freezer in Emmonak. This project allows the YDFDA to increase production and expand its domestic and international markets. The facility will also serve as an emergency command center in the event of ice jams and flooding on the Lower Yukon River.

Opened just in time for the 2014 salmon season, YDFDA already exceeded its estimated new jobs. In the first year of operation, 70 new jobs were created and saved \$2.0 million in salmon processing costs. In addition, the EDA investment provided an additional 300 small business fishermen to participate in the fishery. In the past only 400 of the 700 regional permits operated because of a lack of processing capacity. The increased fish processing operation enabled YDFDA's Yukon Marine Manufacturing Company to increase their boat building of skiffs used by the fishermen; and provides on-the-job training for 150 – 200 high school age students. The students are brought into the company to be trained as receptionists, data entry, and other non-machinery type positions. The Youth Employment Program helps the students build a worth ethic, self-esteem and confidence while readying them for higher education at the University or in Vocational Technical programs outside the region to become managers in the company and in other regional opportunities.

#### American Samoa

Located more than 4,800 miles from the U.S. mainland, businesses in American Samoa struggle with maintaining connection to U.S.-based services. When the only U.S. affiliated bank in America Samoa signaled its intent to close in 2014, EDA helped to ensure that business lending remained available by providing a \$480,000 grant to recapitalize an existing EDA revolving loan fund. Business lending capacity and availability is crucial to small business development and job creation, and the EDA-funded RLF helps meet the need for private capital investment to create jobs within American Samoa. The project is designed to strengthen the economy by promoting entrepreneurship and assisting new and expanding businesses with necessary capital for growth and success.

In addition, using the current Comprehensive Economic Development Strategy (CEDS) as a guide, EDA worked with the Office of Insular Affairs at the Department of Interior to provide technical assistance on how the territory can create additional opportunities for small business growth. To this end, EDA awarded \$50,000 to the Development Bank of American Samoa in 2014 to support a feasibility study for a commercial kitchen incubator. The study will examine the need for the incubator as well as its operating, marketing and design options. The incubator has the potential to assist in the long-term diversification and sustainability of the territorial economy.

Launched in September 2013, the High-Level Economic Dialogue (HLED) between the United States and Mexico has helped to highlight the depth and breadth of our economic partnership and to develop a vision to make North America the most competitive region in the world. By making it easier for goods and people to flow seamlessly between our two countries, HLED endeavors to create more and higher-quality jobs for our citizens and to enhance economic efficiencies and competitiveness on either side of the border. That expansion of US-Mexico trade means more revenue flowing to American businesses; more jobs created for American workers; and more growth in the American economy.

In order to fully take advantage of these opportunities, border communities need to investment in new business development. The City of San Luis recently opened the doors of a business incubator that is focused on helping entrepreneurs develop their businesses and create badly needed jobs. Located in Yuma County near a newly constructed border crossing on the Mexican border, the incubator is in a prime spot for businesses to develop exportable products and technologies. Constructed with \$1.6 million in EDA assistance, the incubator's flexible business spaces are conveniently located in an industrial park with sufficient space for incubator graduates to locate once they have become established. Furthermore, the proximity to the Mexican border and the newly constructed port of entry and adjacent industrial park will create opportunities for products and technologies developed in the business incubator.

In May 2014, EDA announced a \$1.5 million investment in the city of North Little Rock to help the city purchase backup generators and other critical energy-related infrastructure improvements. This equipment will be installed along the major North Little Rock intersection of Highway 70 and I-440 and will support the city's efforts to attract new industry and businesses to the area. The added energy capacity is already expected to serve a major wholesale food distributor and other established and future commercial enterprises. According to grantee estimates, the grant is expected to help create or retain about 350 jobs and generate more than \$60 million in private investment.

City officials never could have anticipated how timely this grant would be when they initially applied to EDA for assistance. On April 27, 2014, only three weeks prior to EDA's announcement, a deadly tornado outbreak roared across the state. These events dramatically underscored the need for backup generators and the modernization of energy infrastructure that companies rely on to continue operating during disasters and to preserve American jobs.

With bountiful sunshine and a highly skilled labor force, California's Coachella Valley is a magnet for new tech-based entrepreneurial firms in the alternative and renewable energy industry cluster. In 2013, the Coachella Valley Economic Partnership (CVEP) of Palm Springs was awarded a \$200,000 Investing in Manufacturing Communities Partnership (IMCP) strategy planning grant to develop an implementation-ready strategy to enhance the region's capacity to attract and expand private investment in the manufacturing sector and increase international trade and exports.

As an outgrowth of that strategy, this California iHub Accelerator Campus Project provides an avenue for economic diversification, job creation, and the development and attraction of targeted advanced manufacturing to the region. In 2014, EDA invested \$784,769 to renovate four buildings on the west side of the Palm Springs International Airport for use as a business accelerator. When complete, the accelerator will contribute to the development of renewable energy technologies, including wind and solar power, which are huge growth sectors in California. This project will create high-skill, high-wage jobs resilient to economic downturns and help the Valley weather the economic impacts of the on-going drought, while helping the region become more competitive in the global arena.

During September 2013, a flood destroyed infrastructure and disrupted transportation, forcing business closures and worker layoffs in the area around Estes Park. In a region still recovering from the economic effects of wildfires the previous year, residents of the popular resort town found themselves cut off from main access roads. Instead of its annual surge of shoppers and visitors, Estes Parks was once again surrounded by emergency crews. National media coverage of the flood damage further amplified the area's economic distress, resulting in cancellations of future guest reservations during the peak fall tourism season.

These back-to-back natural disasters highlighted the region's heightened economic vulnerability: Estes Park was too dependent on tourism-related investment and discretionary tourist visits to the region's major attractions. The community clearly needed economic diversification and resiliency.

In August 2014, EDA announced a \$300,000 grant to the town of Estes Park to conduct a regional economic diversification and industry cluster job retention and recovery strategy in the wake of the Federally-declared flood disaster. One key component of this grant will be developing a specific plan to make use of Estes Park's existing fiber optic ring to deliver improved broadband services to the town and region. The strategy is expected to establish a collaborative action plan in response to the economic damage from these events by providing critical economic recovery services to the Estes Valley to boost business development and job growth in the Northern Colorado region.

# **Commonwealth of Northern Marianas Islands**

In recent years, the Commonwealth of the Northern Marianas Islands has experienced strong economic growth from a recovering tourism industry and growing marine-based industries. Centrally located near the primary seaport and on-island transportation assets, Lower Base Industrial Park on the island of Saipan is an excellent location for marine-based industries. Despite being ideally positioned to take advantage of the Islands' growing economic opportunities, the Park still relied on a World War II-era septic system which severely limited its capacity. Without a modern sewer system, the Park was unable to attract new industry to the region.

In 2014, EDA invested \$1.6 million in Public Works funds to support critical upgrades to the Lower Base Industrial Park, converting the traditional septic system to a modern sewer system. This project allows for additional businesses to locate in the park while protecting vital ground water resources. The Commonwealth expects that the project will lead to the creation of 191 jobs.

For 50 years, EDA grants have helped remove economic barriers and attract capital to Indian country, addressing a broad array of needs from construction to non-construction, technical assistance, and revolving loan fund projects. Between Fiscal Years 2009 and 2014, EDA awarded nearly \$48 million in assistance to Indian tribes to create businesses, build roads and other infrastructure, and develop economic development plans.

In September 2014, EDA provided \$1.3 million in Public Works funding to the Mohegan Tribe of Indians of Connecticut to fund the renovation of an existing facility to create the Mohegan Innovation Center, a business incubator on the Mohegan Indian Reservation. The incubator will support entrepreneur growth across various industry sectors from technology, life sciences, defense, and energy. Not only will the state-of-the-art facility provide the physical space needed for start-ups to grow, it will serve as an innovative workspace that is designed to stimulate entrepreneurial spirit and collaboration between promising new companies. The potential job growth and business expansion made possible by this investment will extend far beyond the borders of the Reservation by creating opportunities for new business growth throughout the state.

As a top tier Historically Black College and University (HBCU), Delaware State University (DSU) serves a diverse student population which spans six colleges, 54 undergraduate degree programs, 25 Masters degree programs and five doctoral degree programs. With strong research and business curriculum, DSU is using its intellectual resources to promote the economic well-being of the state of Delaware.

Founded in 2011, DSU's University Center for Economic Development and Trade (UCEDT) was created with the goal of promoting and supporting entrepreneurship and workforce development. As an EDA University Center, building relationships and connections between the university and the economic development community is a key priority. In this role, UCEDT provides technical assistance to local governments, such as feasibility and impact studies, as well as strategic support and guidance on international trade initiatives for Delaware companies.

In 2014, the Center worked to establish First State Moves the Nation, a jobs and business accelerator in Milford. In collaboration with First State Manufacturing and the City of Milford, UCEDT assists businesses participating in the accelerator program with technical assistance and legal services, as well as provides virtual accelerator services.

Neighborhoods in Washington, DC, like many urban centers across the country, have experienced long-term economic disadvantages, including higher than average unemployment and poverty rates that have persisted since the 1970s. These conditions have handicapped neighborhoods from getting back on their economic feet as the national and regional economics slowly recover from the recent recession. In addition, persistent job loss in various economic sectors inhibits the ability of local populations to secure first-rung employment opportunities.

Operation Hope is tackling these challenges head on. Through its Small Business Empowerment Initiative (SBEI), Operation Hope is working directly with individuals who face challenges finding employment and building wealth by creating and growing small business and entrepreneurial opportunities. By providing the training and tools to support entrepreneurship and the creation of small businesses, the SBEI is helping address the need for communities to provide employment and ownership opportunities for disadvantaged populations.

In 2014, Operation Hope received \$847,783 in financial assistance from EDA to expand its SBEI network in cities across the Northeast, adding a new location in downtown DC. The initiative will also provide access to capital, financial services credit, and individualized management counseling to help small business owners and entrepreneurs expand their businesses.

# Florida

Hit hard by both the Great Recession and deteriorating commercial fishing conditions including a failing oyster industry, Tallahassee Community College (TCC) sought to create an economic driver for the region that would leverage its most precious assets: Wakulla County's natural heritage and biodiversity. In response, TCC created the Wakulla Environmental Institute (WEI) which will offer degrees and certificate programs to bolster the region's environmental science technology, hospitality and tourism, aquaculture management and agribusiness industries. With coastal tourism and recreation as two of Florida's top ocean industries, the state's investment in WEI would help produce graduates to work and innovate in these vital industries statewide.

In May of 2014, EDA announced a \$1.5 million award to TCC to support core infrastructure improvements that will enable the construction of the WEI. The Institute will offer eight environmentally focused degree and certificate programs, including water, wastewater, recycling, alternative energy, recreation and conservation. According to commitment letters by private employers, the project will create 100 jobs over the next three years and attract \$18 million in private investment in numerous fields related to environmental management.

The Food Product Innovation and Commercialization Center (FoodPIC) at the University of Georgia's Griffin Campus is internationally recognized for development of innovative food products and discovery, for implementation of cutting-edge science and technology, and for developing innovative food products. The program forms a strategic alliance with external marketing, technology, and engineering groups to help food companies take a new product from conception, through consumer research, formulation, prototyping, shelf-life analysis, and market launch.

In 2014, FoodPIC broke ground on a new incubator facility that will house research and development services to start-up companies pursuing new product lines in the food industry. Funded through support of a \$1.9 million FY 2013 EDA award, FoodPIC will offer expertise in value added processing, sensory evaluation, quality evaluation, post-harvest handling and storage, food marketing and project management. This investment will enhance and strengthen the state's agricultural cluster by increasing its research and commercialization capacities. The project will create 33 direct jobs at the University of Georgia. A ten-year analysis provided with the application estimates that the impact on the state of Georgia will be the creation of 800 jobs and the leverage of \$92 million in private investment.

In 1973, Hawaii Governor John A. Burns helped create a medical school to train primary care physicians for the Pacific. Since that time, the John A. Burns School of Medicine (JABSOM) has become not only the sole four year medical program in the state and the standard bearer for medical care throughout the Pacific, but a global leader in medical innovation. Medical research achievements at JABSOM include the development of the first red-spectrum cancer detection system, vaccines for West Nile Virus and Dengue Fever, and advances in genetic cloning. One of JABSOM's most noteworthy advancements, a material used in artificial corneas, led to the development of a nuclear cleaning material used by most of the atomic facilities in the world and in microscopic and ingestible identification devices.

When the research-based Hawaii Cancer Center opened its facility next door to JABSOM's downtown Honolulu facility in February of 2013, a medical and biomedical cluster quickly emerged. In 2014, EDA invested \$3 million to construct the Entrepreneur's Sandbox facility adjacent to the Medical School that will provide the medical school faculty, graduates, residents and fellows, as well as researchers at the nearby cancer center with the opportunity to develop their ideas and concepts into working companies. Hundreds of professionals, including more than 66 graduates of the medical school, 225 post-MD residents and fellows, 200 researchers at the cancer center, and the staff of the medical school will be able to provide a 'test bed' for the further development of the prototype devices resulting from their research and education.

At present, the medical and biomedical industry in Hawaii has several thousand employees creating the largest cluster of medical research in the Pacific. The continued development of this cluster is critical to diversifying Hawaii's economy and enhancing the

resilience the tourism and military-based economy. The grantee estimates that this project will create 325 jobs and generate \$75 million in private investment.

In rural communities across America, new and innovative ideas are emerging into new industries. Advances in wind, solar, hydro and geothermal energy are creating new companies and career opportunities. Yet in rural communities, a major hurdle to achieving a high wage job is the lack of the specific technical skills that employers in these developing industries are seeking. In southern Idaho, the Applied Technology and Innovation Center is bridging this skills gap.

Officially dedicated in 2014, the College of Southern Idaho's (CSI) Applied Technology and Innovation Center in Twin Falls was built with \$4.4 million in assistance from EDA in 2011. With the location of several large multinational corporations in the region in recent years, CSI anticipates that this project will create nearly 500 high-skilled, high-wage jobs in the region.

This state-of-the-art, LEED certified facility is being used to provide training to meet the demand for local technicians in wind, solar, hydro and geothermal energy; green construction; and the biofuel industry. The building itself is a learning laboratory. Many of the building's green energy components, such as exposed mechanical systems, measurement and verification equipment, solar photovoltaic and wind energy components, day lighting, natural ventilation, and geothermal heat, are utilized in the CSI curriculum.

For too long, southern Illinois has depended upon two industries for its economic stability: agriculture and mining. Both industries have experienced significant restructuring in recent years. Although the volume of the region's agriculture output has increased, many smaller farms have stopped operating, leaving the region to rely on the production of fewer, large farms. Mining, while still existent in southern Illinois, has decreased significantly in recent years, leaving many unemployed or underemployed. These experiences highlighted the region's economic vulnerability, and in response, southern Illinois looked to build upon its existing resources to diversify its economy.

In September 2014, EDA invested \$1.2 million in Public Works funding to realign roadway at the Southern Illinois Airport Authority Carbondale. The project will develop approximately 65 acres of airport property to support a High Tech Zone anticipated to attract aviation, automotive and technology transfer businesses and increase regional export capacity. This facility is located near the University of Illinois Carbondale campus and will house a workforce training facility for air related fields, including plane maintenance and repair. This project is truly a collaborative effort, including not only the Airport Authority, but also the Greater Egypt Economic Development District, Southern Illinois University and the Jackson County Growth alliance.

Based on a 2012 EDA funded strategic plan, this project is expected to create 75 new jobs through a new High Tech Zone. Businesses from across the region will be able to leverage the existing airport and runway assets in order to provide both domestic and export capacity through this supply chain enhancement project, resulting in new and existing aviation businesses within the emerging aviation cluster in the region.

In Southern Indiana's Jefferson County, the lack of interstate highway access makes rail access critical to attract new industry, investment and expansions of existing industry. However, the 25 mile rail line operating from Madison to North Vernon, Indiana, was constructed with 70-pound track that was insufficient for heavier rail cars. The track limitations caused pricing issues, inhibited the ability of the city of Madison to receive products, and stymied the region's growth.

In July 2014, EDA awarded \$1.6 million to the city of Madison, Indiana, to upgrade critical railroad infrastructure to support increased commerce. By upgrading to 115-pound track, Madison's Meese Orbitron Dunne, a plastics design and manufacturing company, will be able to expand its product line. Meese is dependent upon the rail system for distribution of its products and materials and has already invested \$6 million toward the expansion. According to the grantee, this expansion will create 15 new jobs and save an existing 110 jobs. The increased capacity of the railroad will also assist with future economic development for the region.

Throughout its 50 year history, Indian Hills Community College (IHCC) has included economic development as an essential component of its mission. Serving ten rural counties in southeastern Iowa, IHCC views its role as extending beyond simply providing continuing education opportunities, serving as a leader in addressing the difficult economic conditions facing its community including population decline, lower than average per capita income in the region and net job loss.

IHCC chose to address these issues head on. IHCC established the Regional Economic Advancement Center (REA) – a collaboration of public and private entities with the mission of improving the economic conditions of the region. REA attracted other public and private partners that collaborated to plan, develop and fund a regional business incubator. With EDA funding for both the initial feasibility study and the physical construction, REA constructed the Indian Hills Regional Entrepreneurship Center (REC) on IHCC's north campus in Ottumwa. Built with the assistance of a \$750,000 EDA Public Works grant, the REC is a multi-use, full-service training center and business incubator that opened in 2014.

The Center is a place for businesses to grow and ultimately graduate from the incubation stage to locate in the 10-county region and help to strengthen local economies. The region has a strong presence of bio-processing companies whose primary outputs are corn sugar, corn oil processing, animal feed/animal nutrition, and the enzyme industry. All are used in a large variety of products and processes. Many companies provide add-on services to these bio-processing companies, but they are located outside of the geographic region. The REC is contributing to the success of this cluster environment by offering local incubation space to those companies providing add-on services to the region's bio-processing companies. IHCC predicts that over 450 jobs will be created or saved as a direct result of the business incubator project.

Recent changes in weather patterns have hit the wheat farmers of the American plains hard. Decreased rainfall, increased temperatures, and generally more severe weather have made it difficult for farmers to keep pace with increased global demand for wheat. And the demand is staggering – American wheat brings in more than double the money that corn, soybeans, or beef and veal do. The Kansas Wheat Commission realized a need for more resilience in wheat farming, and they sought to bring together industry, educational institutions, and federal agencies in order to create the Kansas Wheat Innovation Center (KWIC).

Located in the Kansas State University Grain Science Campus, the Center houses a feed mill, a test kitchen, a state of the art greenhouse, and some of the brightest minds in food science to find ways to make wheat more resilient to drought, extreme heat, frigid cold, and myriad of other issues affecting crops. However, while the Commission had the building, it lacked crucial lab equipment needed to make the building function – and to secure a critical grant from the National Science Foundation (NSF). In 2014, EDA invested \$440,000 to purchase equipment and construct a four bay greenhouse and head house to be used for public-private collaborative research and commercialization in wheat biotechnology. With EDA's commitment to expand the facility, the Commission secured the \$10.3 million in NSF funding necessary to grow a center for research and advancement.

The expanded facility will optimize research and commercialization operations at the Kansas Wheat Innovation Center. The Center anticipates inward investments of more than \$12.6 million in the next five years from both U.S. and international corporations, as well as through self-generated funds from sales of new wheat varieties. The project will facilitate the development of new tools and methodologies to accelerate the application of novel discoveries and commercialize these services to be used broadly by the wheat industry. The Center is the first of its kind in plant sciences and represents a new model of agricultural research investment that can be applied to other crops of strategic importance to the U.S. economy.

Bath County is a rural community of less than 12,000 residents in the heart of Kentucky. When the county's largest private expansion, which processes food for manufacturers and food supply chains in North and Central America, announced its intent to expand its Bath County operations, the possibility created a huge opportunity for new jobs in this very small community where every job counts.

Despite having the opportunity in its grasp, the City was unable to meet the infrastructure needs of the company's expansion. To assist with the infrastructure needs of the community, EDA awarded \$2 million to the City of Owingsville expand its wastewater treatment plant serving the Bath County Industrial Park. With this increased wastewater capacity, the company was able to expand, leveraging \$44 million dollars in private investment and creating 272 new jobs. Since the initial investment and expansion, the company has announced plans for another expansion which will create additional investment and employment, adding to the region's growing food cluster.

The Mississippi Delta region has long been isolated from major markets and employment hubs; however, the region's rural geography is no longer the hurdle it once was. Internet connectivity is eliminating isolation, bringing opportunities from across the world to rural Louisiana's front door.

In 2014, EDA awarded \$1.2 million to the town of Vidalia, Louisiana, to support the construction of the Vidalia Technology Center. The Technology Center will house business incubation and the termination/distribution hub of a fiber optic cable crossing from Natchez over the Mississippi River Bridge. The proposed technology will enable emerging entrepreneurs to compete globally through new export promotions, as well as create viable employment opportunities for the region. The enhanced internet connectivity will also enhance efforts to market the City's industrial park and river port.

In addition, broadband technology will support public response to public emergencies and overcome rural isolation which is magnified during disasters — a critical asset in an area that has been impacted by four major disaster declarations in the last 10 years. Access to broadband communication, as well as the Technology Center's redundant power source for the broadband technology, will make both the public and business sectors more resilient and will strengthen and speed the recovery efforts in the wake of hurricanes and other natural disasters.

Working waterfronts and waterways have long been an integral component of the U.S. economy, as well as our nation's cultural and social heritage. Like many coastal New England towns, the city of Belfast, Maine, was built around its waterfront. Dating to before the American Revolution, Belfast has been a center of shipbuilding and maritime commerce for more than two centuries. Yet after 245 years, Belfast's working waterfront struggled to support the needs of modern businesses.

Antiquated infrastructure prevented the waterfront's businesses from expanding and threatened their ability to safely transport their goods. Front Street Shipyard, an internationally-competitive boat repair and construction company, was poised to expand, but the waterfront's main roadway, Front Street, could not accommodate the movement of larger vessels. Another major employer, a food processing firm, was at risk due to water and sewer capacity limitations and road restrictions limiting truck access.

In 2014, EDA invested \$1.9 million to support the construction of utility and road improvements that will enable the shipyard to accommodate vessels up to 200 tons. These improvements will allow the shipyard to increase its competitiveness for international contracts, and further develop its new manufacturing business, including vessel and marine structures construction. This added capacity will also result in the re-shoring of jobs from overseas shipyards, as the Front Street Shipyard can now accommodate work that was previously impossible in the northeast United States. In addition to restoring the City's working waterfront to its historic vibrancy; this project is expected to create 110 high-quality jobs, retain 130 manufacturing jobs, and leverage \$8.7 million in private investment.

Starting a new business is challenging in any industry, but especially so for new food businesses. Not only do many new food businesses lack a licensed commercial kitchen with the right equipment, but food entrepreneurs often encounter structural challenges that prevent them from establishing their enterprise, such as limited access to capital, strict licensing and inspections, a lack of business planning and marketing assistance and product development. Micro-entrepreneurs in the industry also lack critical access to bidding, contracting, and market opportunities, making starting their new businesses even more challenging.

These obstacles are further amplified in East Baltimore, an underserved area of the city with a history of extreme unemployment and economic hardship. In 2014, EDA awarded \$75,000 in local technical assistance funding to American Communities Trust, Inc., to support a culinary enterprise program in East Baltimore. The project will provide critical technical resources and support for entrepreneurs seeking to launch or grow a food-related business. The "Cooking Up Business" program will focus on high-need entrepreneurs with the goal of small business development, wealth creation, and job creation for low-income, immigrant, and minority individuals. Working directly with micro-entrepreneurs and workforce readiness programs, this project will accelerate small business development and create new opportunities for a trained workforce in Baltimore's growing food and restaurant industry.

With nine colleges and universities within its city limits and close to six million people living within a 50-mile radius, Worcester's potential talent pool seems virtually limitless. Yet, Worcester needed an anchor to help retain that talent and translate it into new businesses, new jobs, and new opportunities.

Entrepreneurs and start-ups in Worcester required space and technical assistance to grow and thrive. In May 2014, EDA invested \$1 million to support the renovation of the former Worcester Telegram and Gazette building into the Innovation Center of Worcester. This EDA investment contributes to the City's downtown redevelopment efforts, transforming a dilapidated facility in an otherwise active and vibrant downtown into an outlet devoted to business incubation, business acceleration and supportive business services.

Due to its central location, the Innovation Center is already becoming a hub for Worcester's growing entrepreneur ecosystem. By gaining more space and access to young software developers among the thousands of graduates from the City's concentration of colleges and universities, one of Innovation Center's anchor tenants, TEN24 Digital Solutions, an information technology start-up, has already created fifteen jobs as a direct result of EDA's investment. Job creation estimates indicate that this facility will produce at least 50 direct jobs through Innovation Center businesses and will support 65 jobs over a nine year term.

Starting in 2012, Creative Many (formerly ArtServe Michigan) undertook a project that would help understand more fully how the arts, culture and creative industries are contributing to Michigan's economy. In its 2015 study of Michigan nonprofit arts and cultural organizations, Creative Many calculated that the state's nonprofit creative arts organizations contributed more than half a billion dollars to the Michigan economy during fiscal year 2012 alone.<sup>1</sup>

In the wake of the breakdown of Detroit's automotive industry, creative industries are vital to Michigan's economic reinvention. However, in order to ensure that this growth continues, it is critical to understand the needs and opportunities this emergent sector will create. In September 2014, EDA awarded \$100,000 in Technical Assistance funds to ArtServe to support the second phase of comprehensive research, analysis, and reporting on the state's creative and design industries and in the key regions of Detroit, Ann Arbor, Flint, and Grand Rapids. The research will benchmark Michigan against state and regional competitors in the US, engage creative industry leaders and stakeholders in evaluating the findings, discuss needs and opportunities for cultivating sector growth, highlight case study models, and disseminate and promote findings and recommendations via interactive web, online and print media. The results of the study will provide a foundation for economic strategies to grow jobs and businesses in a wide range of creative and design industries. The scope of the project includes the automotive, technology, and industrial and manufacturing sectors.

Located along the international border with Canada, northern Minnesota's Koochiching County is a remote rural community of approximately 13,000 residents. In May 2013, the area's largest employer, a major paper manufacturer, announced that it was closing two of its four paper machines permanently due to large decline in the industry, eliminating 265 jobs. In such a small community, the impact of this announcement quickly rippled through the region.

Understanding that the impacts to the local economy and workforce needed to be mitigated, local officials formed an Economic Response Team to brainstorm ideas that would help the area recover from the impact of the workforce reduction at the paper mill. In April 2014, EDA awarded \$200,000 in Economic Adjustment Assistance funds to the Arrowhead Regional Development Commission to develop an economic recovery strategy. This project will develop a strategic economic vision that identifies and targets business and industry growth opportunities that will help diversify the area's economy, assess the workforce needs and work to keep the dislocated workers in the region.

The Technology Resource Institute (TRI) is an EDA-supported University Center at Mississippi State University which strives to cultivate innovation by "building out the last mile" of entrepreneurship in rural and distressed counties, including the Mississippi Delta. Teams of Mississippi State University MBA and Business Information Systems students and faculty work directly with local businesses and industries to provide the vital research, consulting, and analysis services. The benefits of this program represent a win-win for both the university and the Mississippi business community — students receive hands-on learning and problem solving by connecting to many of the state's leading businesses, while Mississippi employers receive the research and analytics their businesses need to expand and thrive.

When a steel fabricator in Mississippi that employs over 600 workers faced layoffs due to the global slowdown in heavy construction, the company's leadership came to TRI for help. The company identified a new product, after-market truck bumpers, which they could make using their existing machinery, but lacked the necessary knowledge of the sector. A team of MBA students and faculty working through the TRI program assisted with research on competition, pricing, distribution, and barriers to entry for the truck bumper market. Their research outlined a path to success for the company, enabling them to start a new product line. Not only did the company not have to proceed with their expected layoffs, but the new product line allowed them to hire additional workers.

The City of St. Louis' Municipal Terminal serves barge shipping for St. Louis and other cities and states along the Inland Waterway, while also supporting the City's strong warehouse and distribution cluster. Floods along the Mississippi River in 2008 greatly damaged the South Dock, which handles two-thirds of the St. Louis Municipal River Terminal's output. A study by the St. Louis Development Corporation found that the dock was at the end of its useful life, and if left unrepaired, would cost the port commodity market share, jobs and revenue. Structural integrity has deteriorated so significantly that a "blowout" failure is possible, which would cause injuries and immediately cripple area shipping. The study also indicated that a total collapse was possible in the next several years.

Major repairs to the dock facility were necessary to ensure that the Port remained functional and did not lose the commodity market share and jobs or reduce revenues and opportunities for growth. EDA responded swiftly, investing \$15.6 million to reconstruct the St. Louis Municipal Terminal's South Dock in 2009. Officially completed and fully operational in February 2014, the project not only prevented catastrophic disruption to the area's shipping operations along the Mississippi River and has helped to ensure the continuation of the area's supply chain commerce, but also enabled the port to handle more barges and provide greater fleeting flexibility. The revitalization of the City's Municipal Port has enabled the pursuit of container freight operations, which have redefined national and international trade patterns. The redeveloped port is online to attract new private investment and new businesses such as logistics firms, consolidators, intermodal manufacturers, and trans-shippers.

Welding and metal fabrication are industries booming across U.S. oilfields. Yet while welding school graduates have little difficulty finding work, most employers have difficulty finding properly skilled welders. No place is this more pronounced than in the Canadian oil sands and the Bakken Oil Fields in North Dakota and eastern Montana where high demand for skilled industrial trades workers is creating huge opportunities for well-paying jobs.

Yet, according to the Bureau of Labor Statistics, welders who do not have up-to-date training may face strong competition for jobs. <sup>2</sup> This is especially true in the north central Montana area where welders, pipe fitters and fabricators must be certified in both the Canadian Welding Bureau and American Welding Society standards to work for companies that will assemble modules to ship to the Alberta oil sands areas.

With initial projections calling for least 200 new positions for welders and fitters annually for the period 2013-2017, this demand has made training a top priority for Great Falls College, Montana State University. However, increasing training capacity will require a significant investment to upgrade both the program and the physical plant. With financial assistance from EDA, the College began renovating two existing buildings on the University's campus in 2014 and is procuring industrial trade equipment to develop a trans-border Industrial Trades Training Center. The renovated training center will train welders for certification in both American and Canadian welding standards. As a result of the training and dual certification, ADF International, a Canadian-headquartered company operating in Great Falls, has committed to employing 120 welders, fitters (assemblers), engineers, and other specialized trade workers.

#### Nebraska

In 2009, EDA invested \$2 million in American Recovery and Reinvestment Act (ARRA) funding in the city of South Sioux City to help support infrastructure development in the Roth Industrial Park, a hub for agriculture-related manufacturing firms. This investment proved to be so successful in attracting new businesses to the area that within five years demand at the park had become so high that the existing sewer/waste water infrastructure could no longer meet the demand, inhibiting the city's ability to attract new investment.

As South Sioux City explored alternatives to address this increased demand, they found a proprietary technology that would not only increase the Park's capacity, but could treat the collected waste streams from companies operating across the Park and convert the waste byproducts into a pipeline renewable form of natural gas. In July 2014, EDA announced a \$2.2 million grant to upgrade the sanitary sewer infrastructure in the Roth Industrial Park to incorporate "waste-to-energy" provisions, allowing byproducts of manufacturing to generate biofuels. This project simultaneously increases the Park's ability to attract more businesses and industries, while reducing the region's dependence on fossil fuels and fostering innovation for a more self-sustaining economy.

The project supports the growth of existing and developing industries in the region, where a specialty of advanced manufacturing of meat products has developed, bringing with it new higher-skilled, higher-wage jobs. The grantees estimate that the improvements will help create more than 106 new jobs and attract \$238 million in private investment.

Mining and energy are primary industries in many rural areas in Nevada. Metals are the largest export from the state — in fact, nearly 75% of all gold produced in the United States is mined in Nevada. The state also ranks third in solar energy production per capita in the United States. With the world's largest lithium-ion battery factory, Tesla's Gigafactory 1, expected to open in Storey County in 2016, the state anticipates that lithium mining in Nevada will expand rapidly to supply the facility.

Yet in Nevada, many high-wage jobs often go unfilled due to the lack of technically qualified applicants, particularly in the booming energy and mining fields. Truckee Meadows Community College in Reno is helping fill the gap. With assistance from a \$2.25 million EDA grant, Truckee Meadows began construction in 2014 on the Applied Technology Center. The Center will provide a wide variety of programs, including clean energy (geothermal, wind and solar), advanced mining, materials and manufacturing, and logistics industries — preparing the next generation of Nevadans for the these new and emerging industries.

## **New Hampshire**

The seacoast region of southern New Hampshire has suffered from the severe depletion of fishing stocks which caused consolidation within the industry and displaced hundreds of commercial fishing and fishing-related jobs. Compounding these already devastating losses, the region lost more than 1,185 manufacturing, communications and healthcare jobs through business closures and downsizings. In response, EDA deployed an Economic Development Assessment Team (EDAT) to the state in 2011 to assess these impacts and the need for economic diversification. The EDAT report was clear: southern New Hampshire needed greater support for new and growing businesses, particularly in the areas of business skills and workforce training.

Opened in May 2014, the Regional Economic Development Center of Southern New Hampshire (REDC) was constructed with \$432,000 in assistance from EDA. Located in Raymond, the business and training center provides local entrepreneurs with access to instruction, reference materials, meeting space, and a high-speed Internet computer center. These basic services, which are so essential for new business development, previously did not exist within the region. Since its opening, REDC has hired an in-house business advisor who has counseled over 40 businesses, and the Center recently added marketing and design to its menu of technical assistance services. REDC also hosts its own business development workshops and classes, free of charge to attendees. During this period, REDC also approved 12 loans totaling more than \$1.5 million that will leverage more than \$21 million in private investment into the southern New Hampshire economy, creating and retaining nearly 80 jobs.

With Manhattan as an impressive and unmistakable backdrop across the river, the film, media and communications industry is thriving in New Jersey's Hudson County. Despite the abundance of potential opportunities for job growth in this arena, the wave of opportunity has not taken hold in the community. The County tends to "import" workers for high-skill, high-wage jobs as opposed to hiring from within, leaving Hudson County and Jersey City long term unemployment rates reaching between 166% to 174% of the national average.

In June 2014, EDA awarded \$500,000 to the New Jersey City University (NJCU) and Rising Tide Capital, Inc., a Jersey City-based non-profit, to support the "Start, Sustain, and Expand" program. This investment will provide business development services to more than 200 entrepreneurs in Hudson County's film, media, and communications clusters. The program will recruit, train, and develop entrepreneurs, and provide opportunities for job creation and expansion of businesses that will diversify and grow the regional economy.

Rising Tide Capital will extend its Community Business Academy and its Business Acceleration programs, and the university will provide incubator space and services at its Business Development Incubator (BDI) located on West Side Avenue. Additionally, the New Jersey Small Business Development Center located at the BDI will provide management consulting, coaching, and mentoring in the areas of finance, marketing, and other technical assistance.

In June 2014, persistently low molybdenum prices and high operating costs forced California-based Chevron Mining to close its molybdenum mine near the village of Questa, New Mexico. Opened in 1916, the mine was central to Questa's economy for nearly a century and was the largest private employer in Taos County.

In response to the closure and the displacement of more than 300 workers, EDA moved quickly. EDA awarded a \$75,000 grant for local technical assistance to the North Central New Mexico Economic Development District in August 2014, less than three months after the Chevron Mining's announcement.

This project is playing a critical role in the region's economic recovery by identifying options and opportunities for new businesses and alternative employment. Focusing on long-term recovery, the project seeks to rejuvenate the workforce in Questa, developing workforce training programs tailored to the interests and abilities of the impacted employees.

The Town of Wellsville is a small community located in south-central wooded and rural Allegany County, New York. Ironically, for a town named Wellsville, one of the biggest impediments to retaining existing employers and cultivating new ones was the town's reliance on wells. Without a public water system, existing local manufacturers bore the challenge and expenses of operating from their own private water wells, creating critical issues regarding maintenance and reliability, the need for water storage, and fire flows. These issues increase insurance costs, cause safety issues, and serve as a disincentive for manufacturing facilities to expand, or even to remain.

In 2014, EDA invested \$465,000 to support the expansion of public water into the Town of Wellsville. The infrastructure improvements will serve 17 businesses that employ approximately 700 workers. The project eliminates reliance on aging and unreliable private water infrastructure and will provide the reliable public infrastructure needed to create and retain good paying jobs, lower operating costs due to lower insurance premiums, eliminate the need to maintain private water systems, and provide for greater public safety in case of a fire or other emergency.

Successful manufacturing is predicated upon innovation and implementation of new technologies that will support long-term competitiveness. While this is true in all industries, it is particularly true in aviation manufacturing. Increased pressures by consumers for engines that are fuel efficient and more powerful have led GE, a leader in aircraft engine manufacturing, to develop the new LEAP aircraft engine. This fourth generation aircraft engine is the most technologically advanced engine that the firm has ever produced and is stimulating significant investment in a number of GE manufacturing plants across the country to develop, assemble, and test parts for the new engine. As GE ramps up to begin full production of the new engine in 2016, the company has been examining how they can streamline operations to meet the growing demand beginning on day one.

At the GE facility in Asheville, North Carolina, engineers and workers have been examining how the rotating seals and blades of the LEAP engine could be manufactured more efficiently, which will enable the company to manufacture more engines in a manner that is safer for employees. Currently, these components require manual deburring, or the removing of sharp metal edges to reduce friction and eliminate stress points in the engine. This process can take a skilled technician upwards of nine hours of extremely repetitive motion for a single rotating seal.

In order to meet demand by customers and fulfill preorders for the LEAP engine, the process for deburring these components needs to be significantly reduced. As GE engineers at the Asheville, North Carolina plant considered this challenge, they partnered with Western Carolina University's (WCU) Center for Rapid Product Realization, an EDA-funded University Center, to secure a team of engineering students to design and build an adaptive, automated system to deburr and contour the edges of the GE90-115B Forward Outer Seal. Through this

partnership, the team has designed and programmed a robotic arm to automate the deburring process and has demonstrated how the technology could be utilized in the GE facility.

The initial demonstrations have been positive, and GE is working concurrently to acquire a similar robot to use to begin testing applicability on the manufacturing floor. By adapting this technology, GE anticipates being able to automate and expedite this portion of the manufacturing process soon, which means it will be able to deliver more engines in a timely manner with consistently high quality. Importantly, this innovation also enables GE to redirect the workforce currently focused on deburring to other parts of the manufacturing process that will require less repetitive motion, thereby reducing risk for employee injury.

In order to create a vibrant tech-based economy, various complementary elements must be present: intellectual infrastructure, mechanisms for knowledge transfer, infrastructure, highly skilled technical workforce, sources of risk capital, and an entrepreneurial culture. EDA's University Center program provides technical assistance and research and development tools that universities need to increase productivity, spur innovation, and promote entrepreneurship to help increase long-term regional competitiveness and economic diversification.

Through its incubator near the North Dakota State University (NDSU) campus plus services offered through the University of North Dakota, the EDA University Center at North Dakota State University Research and Technology Park is assisting technology-based companies and entrepreneurs that require highly skilled talent by connecting them to university researchers, which provides a competitive advantage in marketplace. One of these companies, Myriad Devices, is a mobile app company started by NDSU professors and students. With assistance of the business mentors and education programs, the company was able to obtain the required resources and market direction it needed to succeed and has now grown to 17 employees.

Established in 1995, the Youngstown Business Incubator (YBI) has facilitated the creation of high value businesses through collaborative partnerships that promote innovative technologies. Over the last 20 years, the incubator has become a hub for software and technology startups that are investing in the City and has had a profound positive economic impact on downtown Youngstown. The incubator has been one of the most successful incubators in the nation and has even received global recognition; in September 2014, YBI was recognized as the best university affiliated incubator in the world by the University Business Incubator Index in Stockholm, Sweden.

In August 2012, the YBI campus became home the National Additive Manufacturing Innovation Institute (aka "America Makes"), the flagship program in the President's National Network for Manufacturing Innovation. The creation of America Makes has further accelerated the entrepreneurial growth in the region, creating a need for second stage business accelerator space to accommodate this growth and retain companies that are graduating from YBI and utilizing America Makes. In 2014, EDA invested \$3 million in Public Works funds to renovate the Youngstown Business Incubator Tech Block Building #5 to function as a second stage accelerator, additive manufacturing incubator and workforce training facility for the Youngstown region. This project is expected to create 350 new jobs and \$100 million in private investment.

This investment builds upon a long, productive history of EDA investment in Youngstown's entrepreneur revolution. In1998, EDA awarded \$498,000 to the Youngstown Edison Incubator to renovate the incubator. In September 2006, EDA awarded a \$2 million to the Youngstown Central Area Community Improvement Corporation and Youngstown Edison Incubator Corporation to construct the Taft Technology Center, a facility next door to YBI to house graduate companies.

For most of the 20th century, the nickname "Oil Capital of the World" was a tremendous source of pride for the people of Tulsa. The city was one of the most important hubs for the American oil industry, but Tulsa's economic reliance on the oil and gas industry has left the city vulnerable. Not only has the drop in fuel prices damaged Northeast Oklahoma's economy, the changes in the industry have been a major factor in job loss.

In 2014, EDA invested \$1.9 million to support roadway improvements in its unincorporated area. This ongoing project will expand current infrastructure by adding new roadway and widening existing streets to accommodate increased traffic from new businesses in the area. The roadway improvements will encourage companies to build in the area, improving the economic conditions of Tulsa County residents. The project is projected to create 1,020 jobs and leverage \$160 million in private investment.

Established in 1910, the Port of Garibaldi encompasses three coastal towns: Bay City, Garibaldi and Rockaway Beach. For more than 100 years, the Port has been home to numerous commercial enterprises including the lumber industry, tourism, commercial and recreational fishing, and seafood processing. Located at the mouth of Wilson River, the Port's marine-related facilities include moorage for 277 vessels and include an expansive wharf that protrudes into Tillamook Bay approximately 600 feet from the shoreline.

In 2011, severe winter storms accompanied by massive seawater surges destabilized many of the pilings, as well as undermined portions of the earthworks supporting the wharf. The resulting damage compromised the structural integrity of the wharf to such a degree that the Port had to restrict or otherwise limit access to more than 65% of the facility. Given the intense year-round use by both commercial and recreational stakeholders, the loss of access was a socio-economic disaster of regional proportions. In the absence of swift repair or replacement, the projected job loss was in the range of 250-275 direct jobs accompanied by a reduction of annual business revenues in the community approaching \$33,000,000.

Completed in 2014 with the assistance of a \$3 million EDA grant, the upgraded wharf not only saved 225 existing jobs, but now also supports the construction of three 10,000 square foot, two-story buildings on reclaimed/improved wharf frontage. The anticipated projections are 33 jobs per 10,000 square feet of building space (about 100 jobs in total). The investment not only resulted in the replacement of the prior facility, but it includes upgrades that allow both commercial and recreational fishing interests to be more secure and resilient in the face of future disasters.

Industry restructuring and job losses are devastating to any community. The key to overcoming these losses is successfully transforming these setbacks into opportunities. The Pennsylvania Biotechnology Center in Bucks County is doing just that. Changes and downsizing in the sciences and pharmaceutical industries in the greater Philadelphia region, coupled with industry mergers and consolidation, resulted in mid- and late-career separations for highly-educated professionals and shuttered research facilities. By seeing potential in misfortune, the Center is leveraging these closed facilities and unemployed research professionals to create a unique environment where entrepreneurship is flourishing.

In its state-of-the-art research labs and offices, the Pennsylvania Biotechnology Center houses non-profit research organizations and biotech companies under one roof. The Center is committed to helping biotech and life science companies grow while serving as a space to promote regional collaboration. Opened in 2006 in a warehouse fated for abandonment, the Center has become home to 29 commercial companies, 8 non-profits, and 12 companies. In order to accommodate more biotechnology start-ups and to meet the growing needs of its current tenants and the broadening industry, the Center needed to expand.

In 2014, EDA announced a \$4.6 million investment in the Pennsylvania Biotechnology Center. EDA's investment supports the expansion and the addition of 15 laboratories, office space, increased emergency power capacity, and "Reach-in Minus 80 Degrees Celsius" freezer infrastructure. Within nine years, the applicant estimates 378 positions will be created based on trends from the Center's other facilities. As a result, the new state-of-the-art space will attract more than 5 companies to relocate to the region and allow countless biotech start-ups to flourish given new resources.

Strategically located midway between North and South America, Puerto Rico is an ideal location for companies looking to export. Despite being a fertile launching pad for global markets, small and mid-sized enterprises (SMEs), which make up approximately 95 percent of companies in Puerto Rico, often lack the support they need to tap into their export potential. In September 2014, EDA announced an \$800,000 investment to assist the Puerto Rico Trade and Export Company and the Puerto Rico Industrial Development Company to expand the number of SMEs that have achieved export capacity standards, increase operations and job opportunities by opening to new global markets.

Through joint efforts with Puerto Rico Trade and Export Company's current international commercial offices (Panama, Dominican Republic, Spain), the SMEs have an advantage in receiving valuable outreach and export assistance from these Latin America and regional territories to further advance economic development of the island by promoting various initiatives and increase the global competitiveness and readiness of SMEs. The investment also strengthens PR Trade's global linkages by receiving input from international buyers and U. S. federal and state governments on local SMEs responses and outreach to the various agencies based on the quality and readiness of their offer and competitiveness.

One of the project's largest events to date was a forum in December 2014 to inform companies on how to do business with the aeronautical industry, leveraging the announcement of a new Lufthansa Maintenance, Repair Overhaul (MRO) facility currently under construction in Aguadilla. A total of 457 SMEs attended the event. Moreover, the Lufthansa Technik (LHT) team brought 16 employees from Germany, Hungary and Malta to attend the event and meet with potential suppliers.

Newport County, Rhode Island is best known as home to several major military, research and higher education institutions including the United States War College, Naval Station Newport, United States Naval Education and Training Center, and the Naval Undersea Warfare Center. However, this reliance on the defense sector has left the Newport region susceptible to the uncertainty of federal budget reductions and possible Base Closure and Realignment (BRAC).

In recent years, Rhode Islands' defense industry has been directly impacted by reduced funding and delays in receipt of funding, resulting in short and long-term furloughs and some permanent layoffs of a largely high skill, high wage workforce. In response, the Newport area, along with the state of Rhode Island, developed a series of economic development policies to diversify and expand the region's economy by promoting the transfer of defense-related technologies into commercial products.

In 2014, EDA invested \$1.7 million to redevelop a former public school for use as a technology business incubator, accelerator, and innovation center to be known as Newport TechWorks. The state-of-the-art facility will be designed to meet LEED standards and will support defense, marine, climate change, environmental and digital industry clusters and entrepreneurs. The facilities will provide on-going business development, training and a place for tech-driven entrepreneurs to gather and share best practice resources.

For more than 12 years, the University of South Carolina/Columbia Technology Incubator has operated a successful technology incubator in downtown Columbia. The facility has been an incubator to student and faculty startups emerging from the University of South Carolina (USC), a resource for existing business looking to increase competitiveness, and a landing pad for relocating firms entering the Central South Carolina market.

However, in recent years, the incubator experienced significant growth and the current facility was nearing capacity. As a result, the incubator had to slow the rate of acceptance of deserving companies due to space limitations. In addition, the facility had also become inadequate to service the needs of current and proposed clients based on a number of operational, infrastructure, programmatic and financial elements.

In September 2014, EDA awarded \$1,974,000 to the USC/Columbia Technology Incubator, the University of South Carolina and the University of South Carolina Development Foundation to fund construction of a new entrepreneurship and technology commercialization center to serve as the regional hub for USC's and the region's entrepreneurship, incubation and acceleration programs. The Center will include a range of resources to support early stage business ventures and will be the first development in a new technology corridor along Catawba Street within the USC Innovista Innovation District.

The vision for the facility is to design and build a center to support the "lifecycle" of modern day technology ventures. The facility will leverage its proximity to USC's research activities, emerging technologies and student/faculty talent to help create a world class ecosystem. It will facilitate the colocation of entrepreneurs, technology startups, existing/mature technology ventures and the Central South Carolina region's community of entrepreneurial

support organizations to create a powerful mixture of talent, technology, capital and mentoring. The project is estimated to create 698 jobs and leverage \$11.9 million in private investment.

Agriculture has been the life-blood of South Dakota since the first homesteaders arrived on its prairies in early 19<sup>th</sup> century. Agriculture is not only the state's leading industry; it is ingrained in the culture of the state and the identity of its people.

With this long agrarian history, it is only natural that South Dakota is a proven leader in agricultural science innovation. In 2012, EDA invested \$1 million to fund the construction of a Technology Center for Rural Enterprise in Brookings which was designed to bridge the gap between South Dakota State University's (SDSU) research and entrepreneurs who can effectively commercialize those innovations. Completed in 2014, the mixed-use facility is already providing a broad range of commercialization services to small and medium-sized businesses and entrepreneurs. Focusing on the region's growing aquaculture and alternative biofuels clusters, the Center provides a reconfigurable physical structure designed to accommodate pilot scale validation and commercialization activity for the creation of new value-added agricultural industry clusters in distressed rural communities and regions.

Private sector partners have already invested close to \$3 million to support commercialization efforts of the Center's two initial projects, Prairie AquaTech and Cyanosun Energy.<sup>3</sup> Headed by SDSU researchers, Prairie AquaTech is developing soybean and corn-based products that replace fish meal as an aquaculture food, while Cyanosun Energy is using byproducts and waste products at existing ethanol plants to create new, high-value drop-in fuels and chemicals.

Automotive manufacturing accounts for more than one-third of advanced industry employment in Tennessee, serving as an anchor for a nascent ecosystem of research and innovation and employing a highly skilled and educated workforce. In the past 24-months alone, 151 manufacturers have announced expansions or new locations in the Tennessee's Drive for the Future Consortium (DRIVE!) region. The region is now home to six major automotive manufacturers and 582 manufacturers in the automotive supply chain, employing more than 90,000 workers.

In 2014, EDA announced DRIVE! as an Investing in Manufacturing Communities Partnership (IMCP) designated community. The DRIVE! initiative will accelerate the development of a strong and growing automotive cluster in the Tennessee Valley, already the fifth largest region in the country for automotive industry employment. To catapult the competitiveness of its industry to the next level, DRIVE! will invest in the region's public and private research and innovation assets, rapidly accelerating the region's growth while reaching new heights of global automotive leadership. The DRIVE! strategy will integrate the region's research and innovation resources with both training institutions and the entrepreneurial ecosystem in the region to ensure that the region remains globally competitive and continues to emerge as a leading center for advanced automotive technologies.

Traditionally, the Bay City, Texas area has relied on agribusiness and oil and gas to support its economy, leaving the city's economy significantly weakened due to the lack of industry diversity. To address this vulnerability, Bay City looked to jumpstart its manufacturing sector. However, when Tenaris, an Argentinean manufacturer and supplier of pipe for the oil and gas industry, chose Bay City as the location of its first U.S. seamless steel pipe mill manufacturing facility, the City needed infrastructure improvements including roadway and sewer improvements to make that investment come to fruition.

In 2014, EDA awarded \$1.2 million to fund roadway and sewer infrastructure improvements for an industrial development in the northeastern corridor of Matagorda County along Texas Highway 35. In addition to facilitating this foreign-direct investment, these improvements are expected to be an economic driver for new jobs and investments in the Gulf Coast Region of Texas. This project is estimated to create 600 jobs and leverage \$1.2 billion in private investment.

When building a house, you start with a blueprint; when rebuilding your economy, you start with a map. In 2012, the U.S. Virgin Islands' largest single employer, Hovensa, closed its oil refinery in St. Croix, leaving more than 2,000 people out of work. To deal with this devastating blow, the Territory needed to take stock and locate its assets.

In 2014, EDA awarded \$500,000 to assist in the development of a geographic information system (GIS) map of the physical locations of regional assets in Saint Croix. The GIS asset mapping will serve as a critical first step in organizing the resources that can leverage and support integrated workforce and economic development initiatives. Mapping will identify the resources that can be utilized to support economic development goals; lay the foundation for development of a new strategic plan and/or enable the realignment of existing efforts; identify global gaps, redundancies and inefficiencies; identify regional stakeholders leading to aggregate innovative methodology to strengthen the region.

In addition, this project also brings a unique opportunity for collaboration between two universities, Delaware State University and the University of the Virgin Islands (UVI). UVI will assist in the data collection, project team formation, penetration into business and social communities and overall analysis. Delaware State University, an EDA University Center, will use its expertise to evaluate the significance and impact of each major type of regional asset.

A college town located in the heart of Utah's Wasatch Front, Provo is perhaps not the first city most people would think of as a center for the rapidly growing international aviation maintenance industry. Yet with a highly skilled workforce at the heart of a thriving aeronautics and defense cluster, Provo is in a prime position to be a world leader in the aviation industry.

When a large, multinational aviation repair business was looking to expand its footprint at the Provo Airport, the City needed to improve its airport infrastructure in order to seize the opportunity. In September 2014, EDA awarded \$3.5 million to the Provo City Corporation to support improvements to increase access to the airport's service bay hangers and taxi lanes, enabling the development of a new \$45 million maintenance facility at the airport. In addition to serving as a catalyst for expansion and development of other airport infrastructure, this new facility will create added capacity to accommodate growth in international clients from Asia and the Pacific Rim. Grantees expect the project to create approximately 600 high-skilled, high-wage jobs and lead to more than \$65 million in private investment.

## Vermont

Throughout its history, EDA investments have been guided by the basic principle that communities must be empowered to develop and implement their own locally-owned economic development and revitalization strategies based on their region's unique assets and needs. This perspective is built on recognition that without a clear plan, communities will not achieve their economic development goals.

Economic development planning – as implemented through the Comprehensive Economic Development Strategy (CEDS) process– is not only a cornerstone of EDA's programs, but successfully serves as a means to engage community leaders, leverage the involvement of the private sector, and establish a strategic blueprint for regional collaboration. In recent years, EDA has witnessed a growing number of states that have rolled-up the work of their regions' individual CEDS to more effectively address larger, cross-cutting needs and priorities or to attain benefits that accrue beyond regional boundaries that may require economies of scale to implement. By consolidating and coordinating economic development efforts, statewide CEDS cut across county and regional lines to break down silos and ensure that all state agencies are working toward common goals, addressing a growing need for integrated planning and statewide project prioritization, especially for federally-funded projects.

Vermont is one of the first states to embrace this statewide view of economic development planning. The state's economic development leaders spearheaded Vermont 2020, a statewide CEDS document, that lays out goals they hope to achieve over the next few years. Finalized and signed by Governor Shumlin in July 2014, Vermont 2020 is designed to help all of Vermont become more resilient in the face of economic and natural challenges. The strategy sets forth broad-based statewide goals that can be adapted locally, within any particular region of the state.

Martinsville, Virginia, was built on three industries: tobacco, textiles, and furniture. Through the 19<sup>th</sup> century, tobacco was the region's largest cash crop and "plug tobacco" factories dotted the fields around Martinsville. In the 20<sup>th</sup> century, furniture manufacturing dominated. A number of the country's biggest names in furniture manufacturing — Bassett, Hooker, Stanley, Gravely and American Furniture — all got their start in the city. By mid-century, a complementary industry, textiles, also boomed. After Dupont established a nylon production factory in Martinsville in the 1940s, Martinsville would become known as the "Sweatshirt Capital of the World."

In recent decades, however, these industries have experienced significant contractions in response to global economic conditions and new trade treaties. Building on its strong manufacturing base, Martinsville sought to reposition itself long-term as a center for technology development and advanced manufacturing. To assist these efforts, EDA invested \$1.7 million to support construction of a workforce training center, including classroom and high-bay manufacturing space and associated equipment, at the New College Institute in Martinsville.

Opened in September 2014, the new facilities allow the Institute to provide training to students in advanced manufacturing, next-generation healthcare, and entrepreneurship. In order to address the shortage of skilled workforce in those particular sectors, the Institute is partnering with universities and workforce training organizations — most notably with the Commonwealth Center for Advanced Manufacturing (CCAM), Center for Advanced Film Manufacturing (CAFM), and Virginia State University— to provide a direct link for the region's workforce and companies to employment and expansion opportunities of the future. The project is already helping to tie community members to the larger state economy, and it has also helped revitalize a section of Martinsville's downtown, bringing new vibrancy to the community.

EDA's flexible and responsive programs help communities withstand a variety of threats to economic resilience, retain jobs and set the stage for sustained growth. These threats can come from susceptibility to natural disasters, changes in trade patterns, or in the case of Grant County, the loss of a privately operated fire suppression system. The Grant County International Airport Industrial Area's legacy fire suppression system that served its industrial areas was owned and operated by a private party that was not only reluctant to upgrade the system, but considered discontinuing the service. Without fire suppression systems, two major regional employers who were operating in the industrial area faced having to relocate, putting almost 900 jobs at risk.

In September 2014, EDA awarded \$726,415 to construct a new fire suppression system at the Grant County International Airport in Moses Lake. The EDA grant award removed a potential threat to the continuing operation of two historically significant regional employers and will allow for expansion opportunities to service additional facilities in the future. With approximately 2,400 workers employed within this five-square mile industrial area, this project lies within the largest concentration of manufacturing employment in Central Washington. By helping to retain 900 existing jobs and creating the possibility of 400 additional jobs, the water supply redesign and upgrade will become an economic engine for industrial development in the community.

On June 20, 2013, the state of West Virginia celebrated its 150<sup>th</sup> birthday. This milestone comes at a time of economic transition as the state's traditional mainstay industries — coal and chemicals — are facing to rapidly changing markets. From global trade impacts in the chemicals and materials industries, to technology advancements in the coal industry that has significantly reduced the number of miners employed while producing record tonnage, or to environmental concerns that have impacted the type and cost of coal extraction, the state's economy in 2013 looks very different than it did 1863.

With a \$250,000 grant from EDA in 2011, TechConnectWV, directed the planning and implementation of a regional entrepreneurial/innovation action plan, called StartUpWV, to cover the WV Regional Innovation Cluster's 28 counties. StartUpWV is an integrated initiative designed to expand entrepreneurial and business startup efforts that have helped to create new tech-based jobs in high growth industries in West Virginia.

By the time the EDA grant concluded in May 2014, StartUpWV had leveraged approximately \$1.3 million in additional funding from a variety of sources to maintain the project's reach and impact. During the three year duration of this EDA project, StartUp WV helped create several new statewide programs helping advance tech-based economic development; spearheaded the creation of an innovation coalition that includes 162 entities; provided 146 companies with assistance; helped initiate research, tech transfer, and commercialization programs with 13 colleges and universities; and helped launch the nation's only chemistry-based business incubator (ChemCeption). The ChemCeption innovation hub supports any technology involving chemistry, traditional and 'green', from water to plastics, and biotechnology to energy.

Southwest Wisconsin's economy is heavily reliant on manufacturing and agriculture. While the jobs in both sectors are prevalent, they are often low-paying, seasonal jobs with limited benefits for growth or advancement. A key priority for the region is to continue to diversify the manufacturing base and provide for economic resiliency to the existing manufacturing base. In 2010, EDA funded the construction of storm water management facilities to serve 31 acres of a city-owned industrial park. Since that time, 20 acres have been developed by a Swiss-based cheese company that has invested over \$44 million in the region.

With little acreage left for development in the existing industrial park, the City acquired an adjacent parcel that would open up an additional 39 acres for development. In 2014, EDA invested \$800,000 in the city of Platteville through a Public Works grant to extend road, water, and sewer services to serve the industrial park expansion. The project will support job creation for two companies and the expansion of the region's agriculture processing cluster, using sustainable environmentally and energy efficient methods and create jobs paying above-average wages for the region. This project is expected to create 75 new jobs and has the potential to attract over \$50 million in private investment.



The city of Cheyenne, home to over 65,000 residents and the state capital of Wyoming, is taking another step into the new frontier of its economy, the digital technology space. In order to attract outside investment, diversify the local economy, and promote this new industry for the emerging workforce, Cheyenne has engaged in the revitalization of the West Edge Historic District in the heart of Cheyenne's downtown.

But flooding, an all-too common phenomenon in the region, has had severe consequences on local businesses and their ability to grow and create new jobs. Consistent flooding has complicated expansion efforts within the West Edge District. Downtown Cheyenne has a history of flooding and drainage problems. The storm water in the City's downtown area and the near west side can be as much as two feet deep as a result of a typical storm event. A major storm event can produce flooding depths of three feet or greater. This presents both a critical life-safety hazard, as well as a significant property damage hazard.

In July 2014, EDA awarded \$1.6 million to the City of Cheyenne to construct a storm sewer which eliminates the effects flooding has on local businesses. Warehouse Twenty One will be able to expand in West Edge, creating 15 new jobs in the technology and creative fields. Additionally, this project is expected to save over 20 jobs from businesses forced to relocate due to the perpetual damage of flooding.

# **EDA Leveraging Goals for Private Sector**

Section 603(b)(2) of the Public Works and Economic Development Act of 1965, as amended, requires EDA to include in its Annual Report to Congress a discussion of private sector leveraging goals set for investments awarded to (a) rural\* and urban economically distressed areas; and (b) highly distressed areas.\*\*

The following information is provided to respond to those requirements.\*\*\*

(a) EDA's private sector leveraging goal with respect to grants awarded to rural and urban economically distressed areas:

EDA has consistently shown sound results in attracting private capital investment in both rural and urban distressed communities.

In FY 2014, EDA invested 62 percent of its infrastructure and RLF funds in rural areas which grantees expect will leverage almost \$7 billion in private investment; 38 percent of the funds were invested in urban areas which grantees expect will leverage almost \$1.2 billion in private investment.

(b) EDA's private sector leveraging goal with respect to grants awarded to highly distressed areas:

EDA recognizes that importance of private capital investment for successful economic development and recognizes that importance of maintaining significant flexibility to assist those communities that are taking the first steps toward economic growth. Therefore, EDA often makes prudent investments in areas where leverage ratios are lowest.

In FY 2014, EDA invested 45 percent of all its funds in highly distressed areas, and the infrastructure and RLF funds invested in highly distressed areas are projected to generate nearly \$1.3 billion in private investment, based on recipient-estimated projections.
